 - iv. 50% were awarded LIFE scholarship
 - v. 4% got scholarships from departments or outside sources
 - 1. Scholarships are coming from very specific departments (Music, Engineering)
 - vi. About 10% have withdrawn and/or not registered for Spring 22
 - d. Admissions: Up 8% in applications and up about 34% in admits
