#### OPEN SESSION

### I. Call to Order

Chair Moody called the meeting to order, welcomed those in attendance, and asked Trustees in the room to introduce themselves. Secretary Howell confirmed those joining by Microsoft Teams.

Chair Moody called on Mr. Stensland to introduce members of the media. Mr. Stensland introduced Lucas Duprile with the *State*, Tyler Fedore and Jerry Bowen with the *Daily Gamecock*, and Jessica Holdman with the *Post & Courier*.

Chair Moody stated notice of the meeting and the agenda were posted and the press notified as required by the Freedom of Information Act; the agenda and supporting materials were circulated to the Committee; and a quorum was present to conduct business.

# II. System Leadership Council Update

Chair Moody called attention to the System Leadership Council report posted to the Board portal and invited Interim Provost Cutler to provide an update.

Provost Cutler highlighted the System Leadership Council (SLC). He explained the SLC was constituted in 2020 under Priority 5 of the University of South Carolina strategic plan as an advisory body charged with providing counsel to the President regarding USC System initiatives. SLC has worked closely with the System Chancellors in several areas, one of which is strengthening and deepening the University's online initiatives.

Chair Moody thanked Provost Cutler and stated the report was received as information.

#### III. Committee Education

### A. Report from USC Aiken Chancellor Daniel Heimmermann

Chair Moody called attention to USC Aiken Chancellor's report posted to the Board portal and invited Chancellor Heimmermann to provide an update.

Chancellor Heimmermann stated USC Aiken is celebrating its 60th anniversary and the number one goal at USC Aiken is student success. Ninety-one percent of USC Aiken's student body is from South Carolina. In addition, 45% of the students are persons of color and 7% are veterans. USC Aiken will host Governor McMaster on November 30, at which time he will re-sign the law enacted in 2015 by Governor Haley giving all veterans and their families

the ability to enroll in South Carolina's public colleges and universities, regardless of where they live, at the in-state tuition rate.

## B. Report from USC Upstate Chancellor Bennie Harris

Chair Moody stated USC Upstate Chancellor Harris was unable to attend today's meeting. She called attention to Chancellor Harris' report, which was posted to the Board portal for the meeting.
